Yes! To Census 2020

A focus for the City of Houston this spring and summer is the 2020 Census. The census happens every ten years, and the count is used to determine the levels of funding and representation distributed to our communities. The City and County are putting significant resources into getting an accurate count. It is estimated that even a 1% undercount could jeopardize \$250 million in federally administered dollars for the area. Invitations to participate in Census 2020 will begin arriving by mail in mid-March and everyone should receive an invitation by Census Day, April 1. Once you receive the invitation, you can respond online, by phone, or by mail. There are only 9 questions and your responses cannot be shared with anyone. This summer (May-July), census workers will go door-to-door to homes that haven't responded to make sure everyone is counted. The City Planning Department (houstontx.gov/planning) is the lead coordinator for Houston. For general information on the census, see **2020census.gov**.

Brazos Street Bridge - Rebuild or No?

The Brazos Street bridge on Spur 527 has been closed since July 2019 due to safety concerns. The original plan was to reconstruct the bridge; however Houston Public Works is now considering alternatives. These were discussed at a community meeting on February 10 with adjacent neighborhoods. Constable Patrol Update

Contract Constable Program Gets Unanimous Community Support at Harris Commissioner's Court Hearing

On March 3, 2020, the future of the Contract Constable Program was thrown into a state of flux when Harris County Commissioner Adrian Garcia proposed a study to examine "any potential savings that may be realized by eliminating the ability of constables to enter into the [patrol] contracts." Many viewed this proposal as a first step at eliminating the Contract Constable Program. The concern from the community-at-large that their deputies were about to be taken away was swift and overwhelming.

At a March 10, 2020 hearing at the Commissioner's Court, all 8 Harris County Constables and 118 concerned citizens signed up to voice their opinion about the proposal. At the beginning of the hearing and speaking to a packed courtroom that overflowed into the hallways, County Commissioner Steve Radack asked how many people present were there to voice criticism of the Contract Constable Program? The courtroom fell absolutely silent. Every single person present was there to voice support for the program and dismay that the benefits of having additional, largely community-funded police throughout Harris County was being called into question.

Speaking first were the duly elected Constables, both Democrat and Republican, representing each of the eight precincts in Harris County. Each Constable explained the value of the Contract Constable Program to their respective communities. According to the Constables, the various contracts within Harris County put an additional 1,015 uniformed police on the streets. Assuming each deputy is funded 80% by the community that means the county pays for one deputy, but gets five! Further, according to the Constables, last year alone, the Constables fielded over 400,000 calls for service that otherwise would have gone to the overstretched resources of the Houston Police Department and Harris County Sheriff's Department.

Next to speak were the 118 people who had signed up to comment on Commissioner Garcia's. After the third speaker voiced their unconditional support of the Constables, and it appeared that no one was going to speak against the contract deputy program, Commissioner Garcia summarily withdrew the proposal.

Needless to say, I and the other constable liaisons observing the proceedings were thrilled that a political threat to the program had been averted. However, we

will continue to monitor the Commissioner's Court schedule to make sure we speak up if further threats to the program emerge.
